

# Golden Root Acres Boarding Liability Waiver

This agreement is made between **Golden Root Acres** and the undersigned dog owner (hereinafter referred to as “the Owner”) for the care and boarding of the Owner’s dog(s) (hereinafter referred to as “the Dog”).

## 1. General Liability Release

The Owner agrees to release Golden Root Acres from any and all liability arising from injuries, illnesses, or accidents that may occur while the Dog is in Golden Root Acres's care. The Owner understands that Golden Root Acres will take reasonable precautions to ensure the safety and well-being of all dogs in its care.

## 2. Health and Vaccination Requirements

The Owner certifies that the Dog is in good health, free from contagious diseases, and up-to-date on all required vaccinations, including but not limited to rabies, distemper, and parvovirus. The Owner agrees to provide proof of vaccination upon request and accepts full responsibility for any health issues arising from incomplete or inaccurate information.

## 3. Emergency Medical Care and Veterinary Treatment Authorization

In the event of a medical emergency, the Owner authorizes Golden Root Acres to seek veterinary care for the Dog at their discretion, including transportation to an emergency veterinary facility if necessary. This includes but is not limited to, regular veterinary care, emergency care, medications, treatments, or procedures deemed necessary by the attending veterinarian.

The Owner agrees to be financially responsible for all veterinary costs incurred. Golden Root Acres will make every reasonable effort to contact the Owner or their designated emergency contact prior to seeking veterinary care. If the Owner or emergency contact cannot be reached promptly, Golden Root Acres is authorized to act in the best interest of the Dog, as determined by the attending veterinarian.

By signing this waiver, the Owner confirms their approval for Golden Root Acres to seek veterinary treatment, including emergency care, on their behalf.

## 4. Behavioral Issues

The Owner agrees to disclose any known behavioral issues, including aggression, anxiety, or destructive tendencies. The Owner acknowledges that Golden Root Acres is not responsible for injuries, damages, or incidents caused by the Dog's behavior while in its care.

## 5. Interaction with Other Dogs

The Owner understands that the Dog may interact with other dogs during its stay. The Owner accepts all risks associated with such interactions and releases Golden Root Acres from liability for injuries, illnesses, or accidents that may result.

## 6. Owner Responsibility for Damages

The Owner agrees to be financially responsible for any damage caused by the Dog to Golden Root Acres' property or other animals.

## 7. Payment Terms

The Owner agrees to pay all fees associated with the Dog's stay at the time of pick up or as otherwise agreed upon. Any additional fees incurred during the stay, such as emergency veterinary care, will be paid at the time of pick-up.

## 8. Acknowledgment of Risks

The Owner acknowledges that boarding a dog comes with inherent risks, including but not limited to exposure to illness, minor injuries, or stress-related conditions. The Owner further acknowledges that Golden Root Acres does not have a fully fenced property but uses an invisible fence system in conjunction with a shock collar to create a secure boundary for dogs. While Golden Root Acres takes all reasonable measures to ensure the safety and containment of dogs using this system, the Owner understands that no system is infallible, and Golden Root Acres cannot guarantee that a dog will remain within the designated boundaries at all times.

Golden Root Acres will take all reasonable precautions to minimize risks but cannot guarantee that all potential risks will be avoided. By signing below, the Owner accepts these risks and releases Golden Root Acres from their liability.
